      - Mrs. Williams led the discussion to address the terminology of the section, proposing a change of the bylaws to add the term "consecutive" after "three (3) or more....."

MOTION: Motion was made by Erica Williams and seconded by Nancy Gomez to amend the agenda to allow action to amend the bylaws language to insert the word "consecutive" in the Lafayette Charter Foundation Bylaws Section 2.5.2 to now read "The Board may declare vacant the office of any Trustee who has been convicted of a felony, or has been found to have breached any duty arising under Louisiana Law or to be of unsound mind, by any court of competent jurisdiction, or has failed to attend three (3) or more consecutive meetings of the Board of Trustees in any calendar year."
